## Co-op Advertising Program Guidelines Retail Lawn & Garden Program

Mars Fishcare North America, Inc. offers the following cooperative advertising program for Lawn & Garden retail stores stocking PondCare® branded products. We will pay up to \$300.00 based on 5% of the dealer's NET purchases of PondCare® products during that year (purchase history at item level detail required with all claims). Preapproval is required for all advertising to avoid denials/delays. This policy is subject to the guidelines below.

**Dates:** Ads must run between January 15<sup>th</sup> and October 15<sup>th</sup>. Claims must be submitted within 60 days of the insertion.

### Eligible Advertising

Newspaper ads in daily, Sunday, and weekly papers; ads in inserts, magazine sections and T.V. sections of newspapers, and magazines, catalogs, circulars, flyers and the like (excluded are any production, postage and/or distribution costs).

Note: pre-approval of ads is recommended.

**Broadcast Media:** All broadcast media (radio & TV) requires prior approval for reimbursement.

### Mechanical Requirements

Color images, and logos maintained on our public ftp site are the only art & logos that may be used. Directions for accessing our ftp site can be obtained by emailing [retailers@aquariumpharm.com](mailto:retailers@aquariumpharm.com). All advertising must include the appropriate brand logo, product illustrations and the retailer's name and locations where the merchandise may be purchased. Advertisements containing competitive brands will not qualify for cooperative advertising rebate. You must follow the logo guidelines available on our ftp site.

### Co-op Reimbursement

The minimum claim is \$25.00. The reimbursement will be based on the published rate of the print vehicle utilized, less any discount, rebate, finance charge, tax or commission. EXCLUDED are any special position charges any production, postage and/or distribution costs; any advertising containing competitive brands; or any non-compliance with the requirements outlined in this co-op program.

### How To Be Reimbursed

Submit a tear sheet of the ad showing date, name of publication, copy of publication's invoice to you for the insertion and the publication's rate card. For ads in catalogs or circulars, submit a complete copy of catalog or circular, the date it was distributed, copy of printer's invoice, number of pieces printed, and proof of distribution. For broadcast media- requirements will be given at the time of pre-approval. *Also include a copy of your Distributor's invoice(s) covering your purchases.* Attach a bill on your letterhead showing the amount and to whom and where the co-op allowance is to be paid. Mars Fishcare reserves the right to refuse payment when any of the above-mentioned terms and conditions is not met. Product images and logos are supplied on our ftp site.
